

# MountainCare Rug Raffle

## MountainCare Raffle Rules

MountainCare is a 501 (c) (3) nonprofit corporation under the laws of the State of North Carolina. The MountainCare Rug raffle is conducted for the purpose of generating funds for Rathbun House.

Purchase one or more raffle tickets during the MountainCare Rug raffle and you'll be entered to win a handmade wool & silk rug donated by Rug and Home valued at \$8,000. Raffle tickets are \$25 each and benefit Rathbun House. Must be 18 years of age or older. Contest void where prohibited. Raffle begins at 3:00 p.m. September 26, 2019 and ends at 7:59 am on November 1, 2019. All times referenced for the MountainCare Rug raffle are Eastern Time.

## HOW TO ENTER:

**ELIGIBILITY:** Must be 18 years or older to enter. Contest void where prohibited. You need not be present to win. MountainCare and WNC Bridge Foundation employees are not eligible to enter. MountainCare and WNC Bridge Foundation volunteers and board members are eligible to enter.

## SELECTION AND NOTIFICATION OF

**WINNERS:** Winner will be selected at random and announced on the MountainCare Facebook page on November 1, 2019. Winner will be notified by telephone, mail and/or email. If potential winner(s) cannot be reached after 10 days from first notification attempt, or if an entrant is found to be ineligible, or a prize notification is returned as undeliverable, such prize will be forfeited and alternate winner(s) will be selected by random drawing.

**PRIZE SELECTION:** The winner of The MountainCare Rug raffle will receive:

- a handmade wool & silk rug donated by Rug and Home valued at \$8,000

## MODIFICATIONS OR CANCELLATION OF

**DRAWING:** MountainCare reserves the right to cancel or modify the MountainCare Rug raffle.

## INDEMNIFICATION AND LIMIT ON LIABILITY:

As a condition of accepting a prize, winner acknowledges MountainCare is not responsible for any harm, injury, or damage caused to any person or property, proximate or otherwise, through the use of any prize by any person, and agrees to save and hold harmless MountainCare, its principals and employees from any claim of such responsibility. "Harm, injury or damage" includes but is not limited to occurrences beyond the control of MountainCare such as death, bodily injury, property damage, or theft.

**GENERAL:** Ticket purchases are non-refundable and are not tax deductible. By entering the raffle, participants agree that MountainCare, its agents and employees have no liability whatsoever for any

injuries, losses, or damages of any kind which result from the date of award. The prize is non-transferable and cannot be exchanged for cash. MountainCare may use winner's name and likeness for publicity purposes without further compensation. MountainCare is not responsible for any failure of communication or failure of the Internet or its website. MountainCare reserves the right to modify these rules and will give prompt announcement of any rule changes. All decisions of MountainCare are final and binding in all matters related to this raffle. The winner acknowledges MountainCare is not responsible for delivery of rug.

**TAX OBLIGATIONS:** The winner is responsible for all federal taxes. All local and state taxes and fees are the sole responsibility of the winner. For any prizes valued at \$600 or more, MountainCare will file IRS Form W2-G with Internal Revenue Service reporting the value of the prize as income to the winner. Winner must show proof of social security number to MountainCare. This is for tax recording purposes only and will be not be used or released for any other purposes.

**RESTRICTIONS:** By participating in the MountainCare Rug raffle, a participant agrees to be bound by these Official Rules and by all decisions of The MountainCare.
